Room Rental Agreement: All damages must be reported to T&H Staff/Representative immediately.

Cancellation/Rescheduling Policy: Cancellations or schedule changes made within 7 days of a room rental date will be charged a \$100 cancellation fee or a \$50 rescheduling fee. You may reschedule your event by issuing a new rental agreement. If T&H has an emergency situation, every effort will be made to contact the Renter as soon as possible. If the Renter needs to cancel, the deposit will be refunded within 10–14 business days.
